#### Important Notice: Payment / Refund Policy

**All registrations must be pre-paid or guaranteed by credit card to be considered valid. Late registrations [four days prior to class] will be assessed an additional \$20.00 fee and class walk-ins will be assessed a Walk-In Fee of \$50.00. Money Orders, Cash, Pre-approved company checks, or credit cards will be accepted at class check-in. A \$35.00 fee will be charged for returned checks or rejected credit card payments.**
